

**ORDINANCE 2016-1**

**HAVEN TOWNSHIP  
SHERBURNE COUNTY, MINNESOTA**

**ORDINANCE AMENDING ORDINANCE NO. 2014-3 AND SETTING PENALTY  
FOR ORDINANCE VIOLATIONS AND AMENDING CERTAIN SECTIONS  
OF THE HAVEN TOWNSHIP ORDINANCES**

The Board of Supervisors of the Township of Haven, Sherburne County, State of Minnesota, do hereby adopt the following ordinance:

Pursuant to Minnesota Statutes § 609.034, the penalty for any person violating any of the Haven Town Ordinances shall be guilty of a petty misdemeanor or misdemeanor, as stated in the Ordinance.

The following changes shall be made to the Haven Township Ordinances (additions shown in underline and deletions shown in ~~strikethrough~~):

1. **Ordinance No. 400 – Penalties**, as amended by Ordinance No. 2014-3, shall now state:

That any person violating any of the provisions of Haven Town Ordinances, except for Ordinance Nos. 2011-02 and 2011-03, shall be guilty of a petty misdemeanor. The penalty for any violation of this ordinance is thirty dollars (\$30.00). Each day the violation is continued will be deemed a separate punishable offense under this ordinance.

2. **Ordinance No. 2008-02 – Road Design and Standards Ordinance, paragraph 7**, shall now state:

Penalty. Any person violating this ordinance shall be guilty of a petty misdemeanor. The penalty for any violation of this ordinance is thirty dollars (\$30.00). Each day the violation is continued will be deemed a separate punishable offense under this ordinance.

3. **Ordinance No. 2011-01 – Regulating the Parking of Vehicles During Certain Months Within the Town of Haven, Section Three, Subd. 7**, shall now state:

Penalty. Any person violating this ordinance shall be guilty of a petty misdemeanor. The penalty for any violation of this ordinance is thirty dollars (\$30.00). Each day the violation is continued will be deemed a separate punishable offense under this ordinance.

4. **Ordinance No. 2012-3 – Ordinance Regulating Town Road Right-of-Way, paragraph 8**, shall now state:

Any person who violates this Ordinance shall be guilty of a petty misdemeanor ~~and subject to the penalties for such as provided in State law.~~ The penalty for any violation of this ordinance is thirty dollars (\$30.00). Each day of existence of such violation shall constitute a separate offense. ~~If convicted, the person may be assessed costs of prosecution as allowed by Minnesota Statutes Section 366.01, subdivision 10.~~


5. Ordinance No. 2014-3 is repealed in its entirety.
