AN ORDINANCE OPTING-OUT OF THE REQUIREMENTS OF MINNESOTA STATUTES, SECTION 462.3593

WHEREAS, on May 12, 2016, Governor Dayton signed into law the creation and regulation of temporary family health care dwellings, codified at Minn. Stat. § 462.3593, which permit and regulate temporary family health care dwellings; and

WHEREAS, subdivision 9 of Minn. Stat. §462.3593 allows cities to "opt out" of those regulations.

THE TOWN BOARD OF THE TOWNSHIP OF HAVEN, MINNESOTA, HEREBY ORDAINS:

Section 1. Pursuant to authority granted by Minnesota Statutes, Section 462.3593, subdivision 9, Haven Township opts-out of the requirements of Minn. Stat. §462.3593, which defines and regulates Temporary Family Health Care Dwellings.


